16. What is the procedure chapter members should follow when requesting that an asylum application be reopened after it has been administratively closed by the Asylum Office?

A motion to reopen should be filed only for cases in which a final decision has been issued by the Asylum Office. Administrative closure of an asylum application is not a

final decision. If a chapter member wishes to request an administratively closed case be reopened, s/he should write a letter to the Asylum Office explaining the reasons the case should be reopened.

17. When the Asylum Office refers a case to court after an interview on the merits, what does the Asylum Office send to the court? Does the Asylum Office send the asylum application and all supporting documentation filed in that case?

When referring a case to the immigration court, the Asylum Office sends the I-589 along with all supporting documents filed in the case to the court as part of the referral. Chapter members should notify the Asylum Office if not all the documents filed in a particular case are part of the court's file.

a. If a case is referred to court before an interview takes place for lack of jurisdiction or another reason, what documentation is sent to the court?

If a case is not properly before the Asylum Office, only the Notice to Appear will be sent to the court.
